## **Violations and Sanctions**

It is often difficult to determine if participant violations are deliberate or due to lack of knowledge/awareness of program policies therefore the first action usually taken will be a warning stage. In cases where it is clear from the outset that the participant's actions were deliberate staff may need to go directly to the  $1^{st}$  Offense sanction. The Department must be contacted prior to notifying a participant of  $1^{st}$  and  $2^{nd}$  offense sanctions.
